


Faculty Review of Open eTextbooks



- I like that the book is free, and it seems to cover the material at a good level (I have tried another ebook Nature's Principles of Biology and found that my students seemed to miss many points that were skipped over to make room for the really cool bells and whistles that I loved but the students seemed to not find as helpful).
- This book is also quite complete, which means that it could be useful for a number of different biology classes. It could also serve as a backup resource for courses that use other textbooks (especially since it is free).
