


Faculty Review of Open eTextbooks



- The text is well designed with key concepts and learning objectives listed at the beginning of each chapter and subchapter. Practice worksheets, internet examples, and other asides from the text are highlighted and formatted appropriately. Each subchapter ends with key takeaways and exercises.
- Images are used thorough the chapters, some chapters have more than others. There are also a few graphs and other visual aids to illustrate concepts when appropriate.
