

However, a book of this density would benefit from visuals of data, legal institutions, historical figures, etc. The law is already dry - enhancing the study of the law with legal personalities is important for learning comprehension. For example, seeing a photo of

the US Constitution or the Supreme Court, etc. strengthens student learning.
