

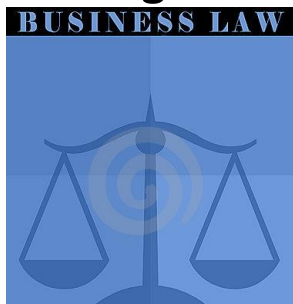


Faculty Review of Open eTextbooks

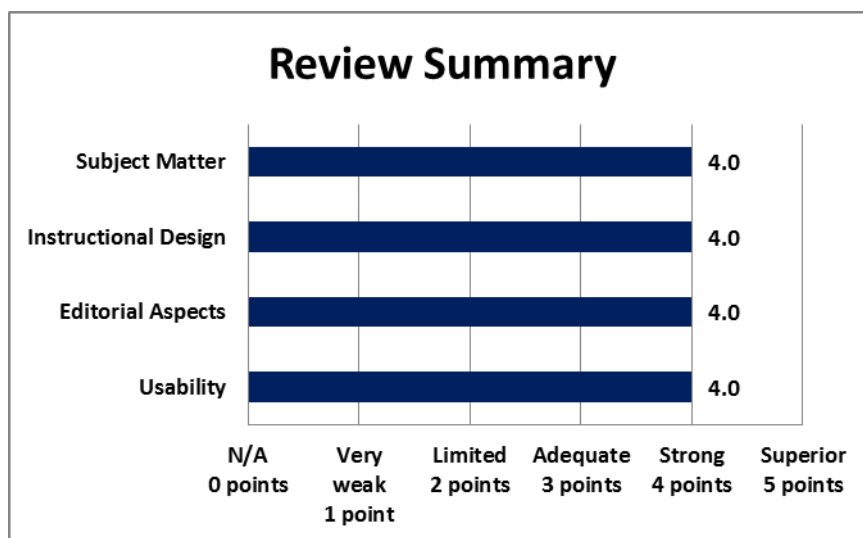

- The book covers the major components of the discipline, reads well and has very helpful and useful supporting technology. It is a good contribution to the discipline and provides good, concise value to the student.

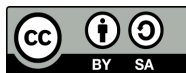
What areas of this textbook require improvement in order for it to be used in your courses?

- As noted above, more clarity and discussion on ethics - this is in the title of the book. Discussing ethics should not be implied simply within in the 'law'. Ethics gets at the core of character, behavior and personal judgment of actions. This can be a delicate subject in any text, but ethics should be taught in this book.
